

## SNCT - Teachers Pay Claim 2021

On behalf of the SNCT Teachers' Panel, I intimate the pay claim for all teachers and associated professionals governed by SNCT terms and conditions for 2021.

The 2021 SNCT pay claim reflects the on-going commitment and professionalism of teachers and associated professionals, which has been brought into sharp focus during the Covid-19 pandemic, and the on-going need to continue the restoration of the pay of teachers and associated professionals.

Therefore, a range of 3%-5% is the financial scope of the claim, depending on other measures and benefits also being considered as part of the pay and reward package, in particular those measures aimed at tackling excessive workload.

The Teachers' Panel believes that the need to provide adequate support and reward for teachers as frontline and key workers should be recognised within the 2021 pay award. The Panel wishes to expedite negotiations, through Extended Joint Chairs, with the aim of reaching a settlement for implementation in April 2021.

### **Parent Evenings**

The education system is under severe pressure at present due to the Covid-19 pandemic and the focus of all schools and teachers must be on teaching and learning. Schools should be deferring all 'normal' school activities at this time including parent evenings. However, some schools are unable to accept the reality of the situation and organising parent evenings. As a consequence the SSTA offers the following advice:

- Teachers should feedback to parents on learner progress within the time available in the school's working time agreement. This can take any agreed format.
- Parents' evenings are not under a Headteachers sole control: they are a matter for negotiation as part of school Working Time Agreement discussions. Such discussions should follow advice given by the LNCT.
- There is no contractual obligation to undertake virtual parents' evenings if they have not been negotiated as part of the WTA.
- The introduction of a virtual approach represents a new working practice and merits full consultation in line with the SNCT Code of Practice on Collegiality.
- Teachers cannot be obliged to undertake remote meetings with parents using their own equipment or from home.
- Teachers are reminded of the Scottish Government instruction 'Stay at Home'

#### **2021 SUBSCRIPTION FEES**

The General Treasurer informed Council that subscriptions would be frozen at 2020 values.

The reduced annual subscription for 2021 for full-time members on a permanent contact will be £175.45 and £87.78 for part time, temporary, job-share, supply and retired members, if their fees are paid by annual direct debit or cheque by 31 January 2021. This saving is clearly of advantage to members and is only available to those who pay before the end of January.

Members who have elected to pay their subscription by annual cheque are reminded that these should be forwarded by 31 January 2021, directly to the Association offices.

The rates for 2021 are as follows:

- Full-time Permanent members £175.45 if paid annually by 31 January 2021, or £191.40 if paid afterwards; £15.95 per month if paid by monthly direct debit.
- Part-time, job-share, temporary, supply and retired members: £87.78 if paid annually by 31 January 2021 or £95.76 if paid afterwards; £7.98 per month if paid by monthly direct debit.

Members who pay annually by cheque are encouraged to transfer to annual Direct Debit. Paying by Direct Debit guarantees that the payment will be taken in time to obtain the discounted subscription. Members on permanent contracts  $(1.0 - 0.81 \, \text{FTE})$  pay the full subscription rate. Members on Part-time contracts  $(0.8 \, \text{FTE})$  and below, Temporary or Supply contracts and retired members pay the reduced subscription rate.

# Are you paying too much tax?

Since launching our professional tax review service last year, hundreds of members have taken advantage of the service and the results so far are eye-opening!

We launched the service after we saw evidence indicating over 50% of taxpayers in the teaching profession have been given the wrong tax code by HMRC causing them to pay too much tax.

The problem is caused because HMRC relies on you checking your tax code and informing them if they give you the wrong code.

The review, provided by leading PAYE tax specialists, The Tax Refund Company, identifies any errors that caused members to pay too much tax and helps them get their money back.

Since launching the service, it turns out significantly more than 50% of SSTA members appear to have been given the wrong tax codes!

So far, 67% of SSTA members using the service have been given the wrong tax code and paid too much tax. The average amount HMRC has given back is £175.51 each, although some members have had over £2,500 back!

If you haven't used the service yet, please bear in mind there is no charge for this review. If you have paid the correct amount of tax, the review is FREE.

If the review concludes you have paid too much tax, The Tax Refund Company will correspond with HMRC to try and recover your money. Where they are successful, there is a fee of £38 for amounts up to £100 or 38p per £1 where the amount recovered is over £100.

This fee only relates to money you overpaid in up to 4 previous tax years. Any money you overpaid in the current tax year will be included as part of the review and recovered free of charge. In the rare event it looks like you have underpaid, only you will be informed, not HMRC. However, for complete peace of mind, if you receive an unexpected tax bill as a direct result of using this service, The Tax Refund Company will pay the bill for you. (T&C's apply)

Please note – HMRC has a deadline for handing back overpaid tax so if you want to avoid losing money you could get back, you should consider reviewing your tax affairs as soon as possible.


